***NOAA's Acquisition & Grants Office, Western Acquisition Division-Boulder, intends to negotiate, on a sole source basis, under authority of FAR 13.106-1(b)(1), with Los Gatos Research, Inc. of Mountain View, CA for the purchase of an Airborne Greenhouse Gas Analyzer Instrument for climate research.

***The Sole Source determination is based on the National Oceanic and Atmospheric Administration's (NOAA) requirement for a mobile greenhouse gas analyzer instrument in support of the Atmospheric Composition and Climate Program (ACCP) from the NOAA Climate Program Office which will meet the requirements of high precision measurements for CO2, CO, CH4, and N2O within the same instrument within a five minute measurement window, provide stable response on aircraft borne observations with minimal calibration or technical support for deployment to field sites. Additionally, the instrument measurements must be intercomparable with existing NOAA's greenhouse gas networks and monitoring instrumentation. Los Gatos Research, Inc. is the only vendor that offers an instrument that meets NOAA's technical requirements.

***This notice of intent is not a request for competitive proposals and no solicitation package is available. However, firms that believe they can fully meet the Government's requirements may submit substantiating documentation in writing to the identified point of contact within 15 days after publication of this synopsis. Such documentation will be evaluated solely for the purpose of determining whether or not to conduct this procurement on a competitive basis. A determination by the Government not to conduct a competitive procurement, based upon responses to this notice, is solely within the discretion of the government. Oral communications are not acceptable in response to this notice.
